- In summary, everything except international and in-country airfare, U.S. domestic and international airport departure taxes, ship or air fuel surcharges, tips to guides and Evolution crew, passport fees, and items of a personal nature, such as laundry, alcoholic beverages, etc.



Cancellations: All cancellations must be made in writing and are effective upon receipt in our office. Cancellations received up to 90 days prior to departure will be refunded all monies less an administrative charge of \$175. Cancellations between 89 and 61 days prior to departure are assessed 50 percent of the cost of the voyage. Cancellations between 60 and 0 days prior to departure are assessed the full cost of the voyage.

Insurance: Travel protection insurance information will be sent to you upon receipt of your reservation form and deposit.

Final Payment: Final payments are due 90 days prior to departure. If your deposit is paid by credit card, the final payment will automatically be charged to the same credit card on the appropriate due date.

Rates and Fares: All rates and fares are accurate and available at the time of publication. Costs are based on a minimum of 15 guests for the expedition voyage, 15 for the Machu Picchu extension, and 2 for the Otavalo extension.
