A WESLEYAN PHOTO ID OR A FACILITY USER PASS w/MAG STRIP WILL BE REQUIRED TO ENTER THE FREEMAN ATHLETIC CENTER AND TO SELECTED HOME ATHLETIC CONTESTS.

1. For the spouse or domestic partner of a Wesleyan employee, a Facility User Pass is required for the yearly charge of \$75.00.
2. Additional passes at \$50.00 each can be purchased for use by children 10 years and older. Young adult dependents are eligible for a pass.
3. If accompanied by an adult, children under 10 may attend Wesleyan athletic events and enter the Freeman Athletic Center free of charge.

The Facility User Pass will provide access to the Freeman Athletic Center and the following activities/facilities:

- Home football games
- Rosenbaum Squash Courts
- Anderson Fitness Center
- Lap/family swim periods
- Wesleyan community skating

The definitions of dependency used by the Internal Revenue Service are also applied by the University in establishing whether a dependent relationship exists. Please see policy statement form for details. Children under the age of 10 must be accompanied by an adult to use the Freeman Athletic Center.
