

## Case Summaries – 2016-2017

### Regulation 1 – Disturbance of the Peace

*The infringement upon the right to privacy of any member of the community is prohibited. Disorderly and disruptive conduct and/or the persistent disturbance of a reasonable level of peace and quiet is also a violation. Students should be aware that repeated violation of this regulation could result in administrative reassignment to another residential unit or area.*

In a simplified hearing, the board considered allegations that four students violated Section II, Regulations 1 and 15 of the Code of Non-Academic Conduct. The board found two students responsible on both charges.

In a Simplified Hearing, the board considered allegations that Student A, B, C, D, and E violated Section II, Regulation 1 and 15 of the Code of Non-Academic Conduct. The board found Students A, B, C, and E responsible. Student D was found not responsible because he stated in a written statement that he was off campus.

In a simplified hearing, the board considered allegations that students A, B, C, D, and E violated Section II Regulation 1 of the Code of Non-Academic Conduct. The board found all students not responsible.

In a simplified hearing, the board considered allegations that student A violated Section II, Regulations 1 and 9a of the Code of Non-Academic Conduct. The board found student A responsible for both violations.

In a simplified hearing, the board considered allegations that students A-F violated Section II, Regulations 1 and 15 of the Code of Non-Academic Conduct. The board found student A responsible for both charges and students B-F were found not responsible.

In a simplified hearing, the board considered allegations that one student violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found the student not responsible.

In a simplified hearing, the board considered allegations that students A and B violated section II Regulations 1 and 4 of the Code of Non-Academic Conduct. The board found student A responsible for regulation 4, but not responsible for regulation 1. The board found student B not responsible for regulation 4, but responsible for regulation 1.

In a Simplified Hearing, the board considered allegations that four students violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found two of the students responsible. The two students were issued a disciplinary warning.

In a simplified hearing, the board considered allegations that students A, B, C and D violated section II, Regulation 1 of the Code of Non-Academic Conduct. The board found all four students not responsible.

In a Simplified Hearing, the board considered allegations that Student A, B, C and D violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found Students A, B, C and D not responsible.

In a Simplified Hearing, the board considered allegations that Student A, B, C, D violated Section II, Regulation 1, 13b and 15 of the Code of Non-Academic Conduct. The board found Students A and B responsible, and found students C and D not responsible.

In a Simplified Hearing, the board considered allegations that Student A violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found Student A responsible.

In a Simplified Hearing, the board considered allegations that Students A, B, C, D and E violated Section II, Regulations 1 and 15 of the Code of Non-Academic Conduct. The board found all students responsible.

In a Simplified Hearing, the board considered allegations that nine students violated Section II, Regulations 1 and 15 of the Code of Non-Academic Conduct. The board found only one of these students responsible.

In a Simplified hearing, the board considered allegations that Students A, B, C, and D violated Section II, Regulation 1, 13e, and 13a of the Code of Non-Academic Conduct. The board found Students A, C and D responsible for 1 and 13e and Student B responsible for 1, 13e and 13a.

In a Simplified hearing, the board considered allegations that Student A, B, C, D, E, F and G violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found all students responsible of this violation.

In a Simplified hearing, the board considered allegations that Student A, B, C, D and E violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found all students not responsible.

In a Simplified Hearing, the board considered allegations that Students A and B violated Section II, Regulations 13b and 1 of the Code of Non-Academic Conduct. The board found Students A and B responsible for 13b and not responsible for 1.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 1, 13b and 14 of the Code of Non-Academic Conduct. The board found Student A responsible for regulation 1 and Students B, C, and D responsible for regulation 14.

In a Simplified hearing, the board considered allegations that a student violated Section II, Regulation 1 and 13b of the Code of Non-Academic Conduct. The board found this student not responsible.

### **Regulation 2 - Harassment and Abuse**

*Harassment and abuse, directed toward individuals or groups, may include at least the following forms: the use or threat of physical violence, coercion, intimidation, and verbal harassment and abuse. Wesleyan University's commitment to nondiscrimination means that intentional discriminatory harassment may be punished more severely than nondiscriminatory or unintentional forms of harassment.*

In a simplified hearing, the Board considered allegations that Student A violated Section II, Regulation 2 and 4 of the Code of Non-Academic Conduct. The board found Student A not responsible for both charges.

In a Joint Student-Administrative Panel, the board considered allegations that one student violated Section II, Regulation 2 of the Code of Non-Academic Conduct. The board found the student responsible and assessed appropriate sanctions.

**Regulation 4 - Property**

*The unauthorized use, or the abuse, destruction, or theft of university property or the property of any of its members, guests, or neighbors is prohibited. This includes but is not limited to all tunnels, roofs, and areas under construction. This regulation prohibits the unauthorized appropriation or "borrowing" of common property for personal use.*

In a Simplified hearing, the board considered allegations that Student A, B, C, D and E violated Section II, Regulations 4 and 9C of the Code of Non-Academic Conduct. The board found Students A and B responsible for Regulations 4 and 9C. The board found Students C, D, and E responsible for violating Regulation 4 and not responsible for violating Regulation 9C.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 4 of the Code of Non-Academic Conduct. The board found Student A responsible for 4 and the student was sanctioned to pay restitution.

In a Simplified hearing, the board considered allegations that Students A and B violated Section II, Regulation 4 and 14 of the Code of Non-Academic Conduct. The board found Students A and B responsible for all charges.

**Regulation 5- False Information**

*Knowingly furnishing false information to a university officer or member of any constituted hearing board acting in performance of his/her duties is prohibited.*

In a simplified hearing, the Board considered allegations that Student A violated Section II, Regulations 5 and 6 of the Code of Non-Academic Conduct. The board found Student A responsible for both charges. The student was issued a disciplinary warning along with the task of writing a letter to those involved in the incident.

**Regulation 9 - Restricted Items/Fire Hazards**

*Starting a fire; the use or storage of kerosene lamps; cooking/heating devices; certain decorative items; explosives, ammunition, incendiary devices and weapons.*

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 9a of the Code of Non-Academic Conduct. The board found Student A not responsible.

**Regulation 13a - Drugs and Alcohol**

*The University prohibits underage and unlawful possession, use, abuse or distribution of illicit drugs and alcohol.*

In a Full Hearing, the board considered allegations that Student A violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Student A responsible for violating Regulation 13a and recommended the student receive a Disciplinary Probation, a counseling referral, a WesWell referral, and an assignment to complete a paper regarding a sober experience at Wesleyan.

In a simplified hearing, the board considered allegations that student A violated Section II, Regulation 13a and 13b of the Code of Non-Academic Conduct. The board found student A responsible for both charges.

In a Simplified hearing, the board considered allegations that one student violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found the student responsible.

In a simplified hearing, the Board considered allegations that Student A violated Section II, Regulation 1, 13a and 13b of the Code of Non-Academic Conduct. The board found Student A responsible for violating Regulation 13a and 13b but not responsible for Regulation 1.

In a Simplified hearing, the board considered allegations that Student A, B, C and D violated Section II, Regulation 13A of the Code of Non- Academic Conduct. The board found students A and D responsible.

In a Simplified hearing, the board considered allegations that Students A, B, and C violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Students A and B responsible for 13a and Student C was found not responsible.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Student A responsible.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Student A responsible.

In a Full Hearing, the board considered allegations that Student A violated Section II, Regulations 13a and 14 of the Code of Non-Academic Conduct. The board found Student A responsible for both charges.

In a Simplified hearing, the board considered allegations that Student A and B violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Students A and B not responsible.

In a Simplified hearing, the board considered allegations that Students A, B, C, and D violated Section II, Regulations 13a, 13b, 13c and 15 of the Code of Non-Academic Conduct. The board found students A and B responsible for violating only Regulation 15, and the other two students not responsible for any of the violations.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Student A to be responsible.

In a Simplified hearing, the board considered allegations that five students violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found three of these students responsible.

In a Simplified hearing, the board considered allegations that Student A, violated Section II, Regulation 13A of the Code of Non- Academic Conduct. The board found student A responsible.

In a Simplified hearing, the board considered allegations that Student A, B and C violated Section II, Regulation 13A of the Code of Non-Academic Conduct. The board found all students responsible.

In a Simplified hearing, the board considered allegations that Student A, B, and C violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Students A, B, and C responsible.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Student A responsible and issued a disciplinary warning.

In a simplified hearing, the board considered allegations that students A and B violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found both students responsible and issued a disciplinary warning.

In a Simplified hearing, the board considered allegations that Student A, B, C and D violated Section II, Regulation 13a and 13b of the Code of Non-Academic Conduct. The board found Student A and Student B not responsible for both charges. The board found Student C responsible for 13a and not responsible for 13b. The board also found Student D responsible for both charges. The students found responsible were issued a disciplinary warning with additional educational sanctions.

In a Simplified hearing, the board considered allegations that one student violated Section II, Regulation 13A of the Code of Non-Academic Conduct. The board found the student not responsible.

In a simplified hearing, the board considered allegations that students A and B violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found student A responsible and student B not responsible. Student A was issued a disciplinary warning.

### **Regulation 13b - Drugs and Alcohol**

#### *Underage Possession or consumption of alcohol*

In a Simplified hearing, the board considered allegations that one student violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found the student responsible, and the student was issued educational sanctions along with health referrals.

In a Simplified hearing, the board considered allegations that Students A and B violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Students A and B not responsible.

In a simplified hearing, the board considered allegations that student A violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found the student not responsible.

In a Simplified hearing, the board considered allegations that Student A, B, C, D, E, F, G and H violated Section II, Regulation 13b and 1 of the Code of Non-Academic Conduct. The board found all students responsible for the charges and issued disciplinary sanctions according to their accumulated points.

In a simplified hearing, the board considered allegations that students A and B violated Section II, Regulations 13a and 13b of the Code of Non-Academic Conduct. The board found student A not responsible and student B responsible for both charges.

In a Simplified hearing, the board considered allegations that Student A and B violated Section II, Regulation 13B of the Code of Non- Academic Conduct. The board found both students responsible.

In a Simplified hearing, the board considered allegations that Student B violated Section II, Regulation 1, 13b and 14 of the Code of Non-Academic Conduct. The board found Student B responsible for both charges and Student B only responsible for Regulation 14.

In a Simplified hearing, the board considered allegations that Student D violated Section II, Regulation 1 and 13b of the Code of Non-Academic Conduct. The board found Student D responsible for both charges.

In a Simplified hearing, the board considered allegations that Student E violated Section II, Regulation 1 and 13b of the Code of Non-Academic Conduct. The board found Student E responsible for both charges.

In a Simplified hearing, the board considered allegations that Student F violated Section II, Regulation 1 and 13b of the Code of Non-Academic Conduct. The board found Student F responsible for both charges.

In a Simplified hearing, the board considered allegations that student A, violated Section II, Regulation 13B of the code of Non- Academic Conduct. The board found student A responsible.

In a Simplified hearing, the board considered allegations that one student violated Section II, Regulation 13B of the Code of Non-Academic Conduct. The board found the student responsible.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Student A responsible

In a Simplified hearing, the board considered allegations that Students 1, 2, 3, 4, 5, and 6 violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Students 1, 2, 3, 4, and 6 responsible, and student 5 not responsible.

In a Simplified hearing, the board considered allegations that Students 1-13 violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Students 1,2,3,4,5,6,7,8, and 10 responsible, and students 9,11,12, and 13 not responsible.

In a Simplified hearing, the board considered allegations that Student A, B, C, D violated Section II, Regulation 13B of the Code of Non-Academic Conduct. The board found Students A, B, C responsible and Student D not responsible.

In a Simplified hearing, the board considered allegations that Student A, B, C, D, E, F, G, H, I violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found all Students responsible.

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Student A responsible.

In a Simplified hearing, the board considered allegations that 11 students violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found 10 responsible and 1 not responsible.

In a Simplified hearing, the board considered allegations that Student A , B, C, D, E violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found all students responsible.

In a Simplified hearing, the board considered allegations that Student A, B, C, D, E, F, G violated Section II, Regulation 13b of the Code of Non- Academic Conduct. The board found students A, B, C responsible but student's D, E, F, G not responsible.

In a Simplified hearing, the board considered allegations that Student A, B, C, D, E, F violated Section II, Regulation 13b of the code of Non-Academic Conduct. The board found only student A and the other students were found not responsible.

In a Simplified hearing, the board considered allegations that six students violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found four of the students responsible, and two of the students not responsible.

In a Simplified hearing, the board considered allegations that six students violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found all of the students responsible.

In a Simplified hearing, the board considered allegations that two students violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found both of the students responsible.

In a Simplified hearing, the board considered allegations that Students A and B violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Student A responsible and student B not responsible.

In a Simplified hearing, the board considered allegations that Student A, B, C, D, E, and F violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Students A, B, C, D, E, and F responsible.

In a Simplified hearing, the board considered allegations that Student A and B violated Section II, Regulation 13b & 1 of the Code of Non-Academic Conduct. The board found Students A and B responsible for 13b and not responsible for 1.

In a Simplified hearing, the board considered allegations that Student A, B, C,D, and E violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found all students responsible.

In a Simplified hearing, the board considered allegations that Students A, B, C, D, E, F, G, and H violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found all students responsible, except for Student H.

In a Simplified hearing, the board considered allegations that Students A, B, C, D, E, and F violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found all students responsible.

**Regulation 13c - Drugs and Alcohol**

*Distribution of alcohol to underage persons*

In a Simplified hearing, the board considered allegations that Student A violated Section II, Regulation 1 and Section II, Regulation 13c of the Code of Non-Academic Conduct. The board found Student A responsible for both charges.

**Regulation 14 - Failure to Comply**

In a simplified hearing, the board considered allegations that students A and B violated section II regulations 14 and 2. The board found both students responsible for 14, and not responsible for 2.

**Regulation 15 – Department Regulations**

*Members of the community are expected to abide by duly established and promulgated non-academic regulations. This is intended to cover the operating regulations of all university programs and facilities. These include, but are not limited to, the policies outlined in the Student Handbook.*

In a simplified hearing, the board considered allegations that students 1-5 violated Section II, Regulations 15 and 13a. The board found one student responsible and the other students were found not responsible.
