## **Purchasing Department Sustainable Practices**

The Wesleyan Purchasing Department takes pride in our past and current initiatives to promote sustainability and to seek supplier diversity when making deals with new vendors. Supplier diversity is an important part of sustainable purchasing. Our preferred vendor list, available on the University website, makes note of any businesses owned by minorities, women, or veterans, as well as small and local businesses. We encourage all departments to take this into consideration when selecting vendors. Our supplier diversity policy is as follows:

> "Wesleyan University is committed to developing mutually beneficial relationships with small, minority-owned, women-owned, veteran-owned, and local businesses. Through quality referrals and equal procurement opportunities, the Purchasing Department serve as a resource to ensure an inclusive business environment to all suppliers."

Currently, we do not have a published sustainable purchasing policy, but we are open to creating one in the future. Some initiatives our department has implemented recently are as follows:

- Began to switch from 30% post-consumer waste recycled paper to 50%, after negotiating a price decrease.
- Introduced **Grounds to Grow On** Keurig coffee cup recycling program has been implemented in 15 departments, with plans to expand in the future.
- Promote the use of WB Mason's Totes Program to save cardboard boxes.
- The new **Unimarket Purchasing Portal** that centralizes large purchases was launched in Fall 2019. It highlights vendors from minority suppliers through Greater New England Minority Supplier Development Council.
- Many of our vendors, such as WB Mason, allow users to shop for products using a sustainability filter. This allows all departments to make environmentally-conscious choices for their office supplies and furniture.
