You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report.

1. an accountant's report;
2. financial information;
3. assets held for investment; and
4. Information regarding any common or collective trusts or pooled separate accounts, in which the plan participates.

Paperwork Reduction Act Statement
