Limited financial support is available to qualified undergraduate students for Private Music Lessons.

## **AWARDS ARE BASED ON:**

- 1. The student's need base as determined by the University Financial Aid Office.
- 2. A recommendation by a Wesleyan Performance Ensemble Faculty member, Ensemble Coach, or Private Lessons Teacher in a written rating and evaluation of the candidate.
- 3. The student's intent to contribute to the musical life of the Wesleyan community through Music Department sponsored activities.

## **ELIGIBILITY REQUIREMENTS:**

(the student must meet all three requirements)

- 1. The student must be eligible for University Financial Aid with an EFC up to \$92,693. This requires one's parents or guardians to have submitted a Financial Aid Form to the Wesleyan Financial Aid Office. In the case of exchange students, Wesleyan must have received a copy of an eligibility letter from the student's home college. In turn, if granted, the student must notify their home college, which then increases the student's tuition allowance.
- 2. Before applying for financial support from the Music Department, students must play in a Wesleyan ensemble for a semester or complete a semester of private lessons at Wesleyan. A recommendation from the instructor is required.
- 3. You must indicate your intention to contribute to the musical life of the Wesleyan Community as your ability allows by participating in one or more of the Music Department sponsored performing ensembles for which credit is offered, or in some other capacity as designated by the Music Department.

# **APPLICATION REQUIREMENTS:**

- 1. During the Interview/Registration period you must inform your Performance Ensemble Faculty member, Ensemble Coach or PL Instructor that you are applying for financial assistance. Instructors will submit the required recommendation forms.
- 2. Financial assistance is determined on a per semester basis. You must re-apply at the beginning of each semester in order to be considered for financial assistance.

## **FACTS:**

1. Even with support, everyone is responsible for paying a percentage of the cost of their private lessons. The maximum support available is 80% of the \$780 Private Lessons Fee. These percentages are estimates and are not guaranteed.

- 2. Financial support is available for only one set of lessons per semester.
- 3. STUDENTS WILL BE BILLED FOR ANY STUDENT ABSENCE INCURRED.
- 4. If a student incurs 3 absences and will not be able to complete 10 lessons for credit, the student **may** have the option to pay for a makeup lesson to meet the minimum requirement of 10 lessons for credit, if the instructor agrees.
- 5. This application is for the Fall 2025 semester only. Students must re-apply each semester.
- 6. Music Majors requesting financial support in addition to the waiver must complete this application by the deadline.
- 7. Information regarding financial support awards will be available the second week of lessons. You will be notified of your award by the Private Lessons Coordinator. Submitting this application does not guarantee an award.
