Regulation 1-Disturbance of the Peace

The infringement upon the right to privacy of any member of the community is prohibited. Disorderly and disruptive conduct and/or the persistent disturbance of a reasonable level of peace and quiet is also a violation. Students should be aware that repeated violation of this regulation could result in administrative reassignment to another residential unit or area.

In a simplified hearing, the board considered allegations that Students A through O violated Section II, Regulation 1 of the Code of Non-Academic Conduct. Students A through G were found responsible for violating Regulation 1 but students H through O were found not responsible for the charge. The board assigned students A through O one point and a disciplinary warning.

In a simplified hearing, the board considered allegations that Students A, B, C, D, E, F, and G violated Section II, Regulations 1 and 14 of the Code of Non-Academic Conduct. Students A and B were found responsible for violating Regulation 1, but not responsible for violating Regulation 14. Students C through F were found not responsible for both charges. The board assigned students A and B one point, a disciplinary warning and a reflective paper.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulations 1, 9D, and 10 of the Code of Non-Academic Conduct. Student A was found responsible for all three of these charges and the board assigned points as well as educational sanctions.

In a simplified hearing, the board considered allegations that Students A-E violated Section II, Regulation 1 of the Code of Non-Academic Conduct. Student A was found responsible and the board assigned one point as well as an educational sanction.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulations 1 and 2 of the Code of Non-Academic Conduct. The board found the student responsible for both charges and assigned 3 points and additional educational sanctions.

In a simplified hearing, the board considered allegations that Students A, B, C, D, E, and F violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found Students A-E responsible and assigned them points and a disciplinary warning

In a simplified hearing, the board considered allegations that Students A,B,C,D,E, and F violated Section II, Regulation 1 of the Code of Non-Academic Conduct. The board found Students A and C responsible, and Students B, D, E, and F not responsible.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 1 and 14 of the Code of Non-Academic Conduct. The board found the student responsible for both charges and assessed points and an educational sanction.

In a simplified hearing, the board considered allegations that 8 Students violated Section II, Regulation 1 and 13B of the Code of Non-Academic Conduct. The board found all students responsible for the violations and assigned points as well as educational sanctions.

In a Simplified Hearing, the board considered allegations that student A violated Section II, Regulations 1 and 4 of the Code of Non-Academic Conduct. The board found the student responsible for both charges and assigned one point and an educational sanction.

Regulation 2 – Harassment and Abuse

Harassment and abuse, directed toward individuals or groups, may include at least the following forms: the use of threat of physical violence, coercion, intimidation, and verbal harassment and abuse. Wesleyan University's commitment to nondiscrimination means that intentional discriminatory harassment may be punished more severely than nondiscriminatory or unintentional forms of harassment.

In an interim student/administrative panel hearing, the board considered allegations that Student A violated Section II, Regulations 1, 2, 13B, 13D, 14. The board found the student responsible for all the charges and the student was suspended from campus effective immediately. The student was provided multiple stipulations that must be completed prior to returning to campus.

In a Full Hearing, the board considered allegations that Student A violated Section II, Regulations 1 and 2 of the Code of Non-Academic Conduct. The board found the student responsible for the violations and assigned points as well as a disciplinary warning and other educational sanctions.

Regulation 4 – Property

The unauthorized use, or the abuse, destruction, or theft of university property or the property of any of its members, guests, or neighbors is prohibited. This includes but is not limited to all tunnels, roofs, and areas under construction. This regulation prohibits the unauthorized appropriation or "borrowing" of common property for personal use.

In a simplified hearing, the board considered allegations that Students A through R violated Section II, Regulations 4 and 13b of the Code of Non-Academic Conduct. The board found 8 students not responsible for all charges; 9 students responsible for 13b, and 1 student responsible for both 4 and 13b. The responsible students were assigned points and asked to plan and host a new event.

In a simplified hearing, the board considered allegations that Students A and B violated Section II, Regulation 4 of the Code of Non-Academic Conduct. The board found both students responsible and assigned points and a disciplinary warning.

In a Simplified Hearing, the board considered an allegation that Students A, B, C, E, F, G, H, I, J, K, L, M, N, and O violated Section II, Regulation 4 and 14 of the Code of Non-Academic Conduct. The board found all students not responsible.

In a Full Hearing, the board considered allegations that Students A, B, C and D, violated Section II, Regulations 4 and 14, and that Student E violated Section II, Regulations 4 and 7. The board found all students responsible for violating Regulation 4, Students A, B, and C responsible for violating Regulation 14, and Student E responsible for violating Section 7. The board assigned students A and B a Disciplinary Warning and Students C, D, and E were put on Disciplinary Probation and assigned points.

In a Simplified Hearing, the board considered allegations that student A violated Section II, Regulations 1 and 4 of the Code of Non-Academic Conduct. The board found the student responsible for regulation 4, but not responsible for regulation 1. The student was assigned one point and an educational sanction.

Regulation 10 – Reckless Endangerment

Creating condition(s) or an environment that endangers, or has the potential to endanger, other members of the community or property is prohibited. Failure to take reasonable constructive action to remedy such conditions may also constitute a violation.

In a simplified hearing, the board considered allegations that Students A-C violated Section II, Regulations 10, 13A, 13C; additionally Student C violated Regulation 15 and Student D violated Regulation 13A of the Code of Non-Academic Conduct. The board found Students A-C responsible for 10, students A, C, and D responsible for 13A and Student C responsible for 13C and 15. The students were all assigned a number of points reflecting their level of responsibility as well as educational sanctions.

In a full hearing, the board considered allegations that Student A violated Section 2, Regulation 1, 10, 13G and 14 of the Code of Non-Academic Conduct. The board found Student A responsible for 10 and 14 and assigned a disciplinary probation.

Regulation 13a – Drugs

The possession, use, manufacture, distribution, or dispensing of illegal drugs or controlled substances by any member of the Wesleyan community.

In a full hearing, the board considered allegations that Students A-H violated Section II, Regulation 13A and 9E of the Code of Non-Academic Conduct. The board found Student A responsible for both and assigned a deferred suspension as well as a variety of additional educational sanctions. The board found Students B-H responsible for 13A and assigned a combination of points and educational sanctions.

In a Simplified Hearing, the board considered allegations that student A violated Section II, Regulations 13a and 14 of the Code of Non-Academic Conduct. The board found Student A responsible for violating 13a and 14 and assigned points and a disciplinary warning.

In a simplified hearing, the board considered allegations that Student A-C were charged with violation of 13A of the code of non-academic conduct. Student A was found responsible and assigned points as well as a variety of additional educational sanctions. Students B and C were found not responsible.

In a Full Hearing, the board considered allegations that Students A, B, C and D violated Section II, Regulation 13a of the Code of Non-Academic Conduct. The board found Students A, B, C and D responsible and assigned points and a disciplinary warning.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13A of the Code of Non-Academic Conduct. The board found Student A responsible and assigned one point and a disciplinary warning.

In a simplified hearing, the board considered allegations that Students A, B, C, D, and E violated Section II, Regulation 13A and 15 of the Code of Non-Academic Conduct. The board found Students A and B responsible for 13A, but not responsible for 15 and assigned points and a disciplinary warning.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13A of the Code of Non-Academic Conduct. The board found the student responsible and assigned points and a disciplinary warning.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13A in the Code of Non-Academic Conduct. The board found the student responsible and assigned points as well as an online marijuana education requirement.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13A and 14 of the Code of Non-Academic Conduct. The board found the student responsible for both violations assigned points and a disciplinary warning.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13A of the Code of Non-Academic Conduct. The board found the student responsible and assigned points as well as fire safety community service.

In a simplified hearing, the board considered allegations that Students A and B violated Section II, Regulation 13A of the Code of Non-Academic Conduct. The board found Student A responsible and Student B was not responsible. The board assigned points as well as an assignment to speak to an Area Coordinator for the responsible student.

Regulation 13b – Underage Possession or Use of Alcohol *Underage possession or consumption of alcohol anywhere on university property or at university-sponsored events.*

In a Simplified Hearing, the board considered allegations that a group of students violated Section II, Regulations 13b and 1 of the Code of Non-Academic Conduct. The board found students A and B, the room occupants, responsible for both charges and 13c, with which they were additionally charged. The board found more likely than not that students A-G responsible for 13b and all other students present at the gathering responsible for 1. Student H was not present at the gathering and was found not responsible. Student I was also found not responsible.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulations 13B and 14 of the Code of Non-Academic Conduct. The board found Student A responsible and assigned points as well as an educational sanction.

In a Simplified Hearing, the board considered allegations that students A, B, C, and D violated Section II, Regulation 13b of the Code of Non-Academic Conduct. Additionally a student E and student D were charged with 13c. The board found all students responsible with the exception of student E and assigned points and disciplinary warnings.

In a Simplified Hearing, the board considered allegations that Students A, B, C, D, E, F, G, H, and I violated Section II, Regulation 13b of the Code of Non-Academic Conduct and Student I violated Section II, Regulation 13c. The board found all students responsible for 13b and student I responsible for 13c and assigned points and disciplinary warnings.

In a Simplified Hearing, the board considered an allegation that student A violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Student A responsible for violating 13b and assigned points and a disciplinary warning.

In a full hearing, the board considered an allegation that Student A violated Section II, Regulation13B of the Code of Non-Academic Conduct. The board found Student A responsible and assigned points as well as a variety of additional educational sanctions.

In a simplified hearing, the board considered allegations that Students A and B violated Section II, Regulations 13b and 13a of the Code of Non-Academic Conduct. The board found the students responsible for 13a and assigned points and additional educational sanctions.

In a simplified hearing, the board considered allegations that Students A, B, C, D, E, F, G, H, I, and J violated Section II, Regulations 1 and 13b of the Code of Non-Academic Conduct. The board found all students not responsible for violating regulation 1. Students A, B, C, F, G, H, I, and J responsible for 13b assigned points and a disciplinary warning.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulations 13b and 15. The board found the student responsible for both charges and assigned points and additional educational sanctions.

In a simplified hearing, the board considered allegations that Students A, B, C, and D violated Section II, Regulation 13B of the Code of Non-Academic Conduct. The board found the students responsible for 13B assigned points and educational sanctions.

In a simplified hearing, the board considered allegations that Students A-T violated Section II, Regulation 13B of the Code of Non-Academic Conduct. The board charged Student A with violating Regulation 13A as well and Students A-E were found responsible for 13B, Student A was found responsible for 13A. All students were assigned points as well as an assignment to meet with an AC.

In a full hearing, the board considered allegations that Student A violated Section II, Regulation 13B of the Code of Non-Academic Conduct. The board found the student responsible and placed the student on disciplinary probation along with a referral to BMI and a CAPS follow up.

In a Simplified Hearing, the board considered allegations that students A, B, C, and D violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found the students responsible for the charge and the students were assigned one point each.

In a Simplified Hearing, the board considered allegations that students A, B, C, and D violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found the students responsible for the charge and the students were assigned points and a disciplinary warning.

In a Full Hearing, the board considered allegations that Student A violated Section II, Regulations 1, 2, 13b and 14 and Student B violated Section II, Regulations 1, 13b, and 14. The board found Student A responsible for all charges and Student B responsible for 1 and 13b. The board placed Student A on disciplinary probation and student B received a disciplinary warning and points were assigned as well.

In a Simplified Hearing, the board considered an allegation that Students A, B, C, D, E, F, G, H, I, J, K, L, M and N violated Section II, Regulation 13b of the Code of Non-Academic Conduct. The board found Students A, B, and C responsible. The board also considered an allegation that Students A and B violated Section II, Regulation 13c of the Code of Non-Academic conduct. The board found Students A and B not responsible.

In a simplified hearing, the board considered allegations against students A, B, C, D, E, F, and G. All students were charged with violations of regulation 13b and 14, and students A and B were additionally charged with 13c. Student A was found responsible for all 3 charges, and Student B was found responsible for 13b and 13c. Students C, D, E, F, and G were found responsible for 13b only. Points were assessed as well as an educational sanction.

In a Simplified Hearing, the board considered allegations that Students A, B, C, D, E, and F violated Section II, Regulation 13b of the Code of Non-Academic Conduct and Student F also alleged to have violated 13C. The board found Students A, B, C, and D responsible for 13B and assigned the students points. Student A also received an additional educational sanction. Student F was found responsible for both violations and assigned points as well as an educational sanction. Student E was found not responsible for 13B.

In a simplified hearing, the board considered allegations that 7 students violated Section II, Regulation 1, 13b and 13c of the Code of the Non-Academic Conduct. The board found 2 students responsible for 13B and the 1 student responsible for 13C. The responsible students were assigned points and a disciplinary warning along with an educational sanction.

In a Full Hearing, the board considered allegations that Student A violated Section II, Regulations 13b and 14. The board found the Student responsible for violating both Regulations. The Student was assigned points, required to follow up with WesWell and CAPS and was placed on disciplinary probation.

In a Simplified Hearing, the board considered an allegation that Students A, B, C, D, E, F, G, H, I, J, K, L, M, O, P, Q, violated Section II, Regulation 13b of the Code of Non-Academic Conduct and Student B also alleged to have violated 13C, and Student A for violating 14. The board found Students A, B, C, D, E, F, G, H, I, J, O, P, Q, responsible for 13B and assigned the students points. Student A was found responsible for both violations and assigned points as well as an educational sanction. Student B was found not responsible for 13B.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 13B and 13E of the Code of Non-Academic Conduct. The Student was found responsible for both charges and assessed a disciplinary warning and points.

Regulation 13c – Distribution of Alcohol to Minors

Distribution of alcohol to underage persons anywhere on university property or at university-sponsored events.

In a simplified hearing, the board considered allegations that Students A-R violated Section II, Regulation 1 and 13B of the Code of Non-Academic Conduct. Students A, B, and C were charged with 13C, and A and B were also charged with 13A. The board found students A and B responsible for all violations. Student C and D were found responsible for 1 and students E-R were found responsible for 1 and 13B. The sanctions involved points and educational sanctions, which varied for each individual.

In a simplified hearing, the board considered allegations that student A violated Section II, Regulation 15 and 13c of the Code of Non-Academic Conduct. The board found the student responsible for violating 15, but not 13c and were assigned points and an educational sanction.

Regulation 13d – Possession of False Identification

The possession of false identification.

In a Simplified Hearing, the board considered an allegation that Student A violated Section II, Regulation 13D of the Code of Non-Academic Conduct. The board found Student A responsible and assessed the student points and an educational sanction.

Regulation 14 – Failure to Comply

Members of the community are expected to comply with reasonable requests made by university personnel acting within the capacity of their responsibilities, including requests for adequate identification.

In a simplified hearing, the board considered allegations that Student A violated Section II, Regulation 14 and 15 of the Code of Non-Academic Conduct. The board found student A responsible and assigned a point as well as an educational sanction.

In a simplified hearing, the board considered allegations that students A, B, and C violated Section II, Regulation 14 of the Code of Non-Academic Conduct. The board found students A and B not responsible for this charge, but Student C responsible for regulations 13b and 13e. This student was assessed one point and a disciplinary warning.
